

WAIVER OF LIABILITY
SHORTLAND ALPINE CLUB CO-OPERATIVE LIMITED

1. Shortland Alpine Club Cooperative Ltd has put in place a number of preventative measures to reduce the spread of COVID-19. However, the Club cannot guarantee that you, your guests or anyone else will not become infected with COVID-19. Further attending Mulubinba Lodge could increase your risk of contracting COVID-19.
2. The Club has provided you a **COVID-19 Safety Plan**. You must familiarise yourself, and comply with the Safety Plan and ensure your guests and any minors in your care do the same. You must also comply with any direction from the Club's Board, the Booking Officer or Lodge Captain. You must acquaint yourself with those requirements prior to making a booking for accommodation or visiting Mulubinba Lodge for any reason whatsoever. A copy of the Safety Plan is also available at Mulubinba Lodge.
3. You must also comply with all Federal and State Government social distancing requirements and guidelines including the requirement to remain at a distance of 1.5 metres from any other individual that is not a part of your household.
4. You are also responsible for ensuring that all minors you are parent and/or guardian to, together with ensuring that all your guests, comply with all COVID-19 preventative requirements, which include the Club's COVID-19 Safety Plan..
5. Any breach or non-compliance with any COVID-19 preventative requirements may lead to a direction being issued to you and/or your guests to immediately vacate the premises. If such a direction or any instructions by the Lodge Captain, The Club's Board or a Department of Health officer is issued, you must comply with it. Failure to comply may lead to Police being called for removal from Mulubinba Lodge.
6. You voluntarily agree to assume all of the foregoing risks and to accept the sole responsibility for any injury or illness to you or any of your guests which you and/or they may experience or incur in connection with attendance at Mulubinba Lodge. You hereby release, discharge and hold harmless the Club, its directors, contractors, volunteers, agents and representatives of and from any claims including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any claims based on acts, omissions or negligence of the Club, its directors, contractors, volunteers, agents and representatives whether the COVID-19 infection occurs before, during or after your attendance at Mulubinba Lodge or engaging in any activity associated with, or in the vicinity of Mulubinba Lodge.
7. You also agree that in the event that physical / social distancing is not being adhered to, or this Safety Plan is not abided by, or for any other reason that might lead to fines being issued by any authority, such fines to an individual are to be paid by the individual and any fines of a corporate nature issued to the Club or the Board, where possible under common law, are to be paid, in equal proportions, by the individuals who commit the offence/s.
8. You further agree that if you and/or any of your guests display any flu like symptoms following the booking of accommodation, during your period of visiting Mulubinba lodge, as well as 14 days following your visit to Mulubinba Lodge; then you must immediately notify the Booking Officer or the Board.
9. You confirm that the contact details provided on the Mulubinba Booking Form are the correct details and that you can be contacted directly, or through your sponsoring member, at any time.
10. The Board reserves the right to cancel any or all bookings at short notice. The refund conditions as detailed in the COVID-19 Safety Plan shall apply
11. This signed form must be returned with your Accommodation Booking Request for eligibility to be considered for accommodation at Mulubinba Lodge.
12. By signing this form you acknowledge that you have read, understand and agree to the above conditions and you also acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you and/or your guests may be exposed to or affected by COVID-19 by attending Mulubinba Lodge, or engaging in any activity associated with, or in the vicinity of Mulubinba Lodge and that such exposure or infection may result in personal injury, illness, permanent disability or death. You further understand that the risk of becoming exposed or infected by COVID-19 at Mulubinba Lodge, or its vicinity, may result from the actions, omissions or negligence of yourself or others including but not limited to any staff or contractors of any organisation and/or volunteers.
