# SHORTLAND ALPINE CLUB 2015 SPRING NEWSLETTER

#### 2015 SKI SEASON WRAP-UP

This year's snow season got off to a flying start with snow on the opening long weekend... and then????

That early May snow all melted and apart from a miserable 2cm's in mid-June we had to wait until late July for a resort wide solid base of natural snow to settle. However, thanks to the resort's snow making efforts, many runs on Front Valley, Centre Valley, Mt Perisher and Blue Cow were ready for the July school holidays and these were interlinked by strategically making snow on access trails and runs.

According to <a href="http://www.onthesnow.com.au">http://www.onthesnow.com.au</a>, last season a total of 201cm's of natural snow fell, occurring over 29 days, and the biggest single snowfall event depositing 45cm's in the last week of August. This year saw fairly uniform snowfall once July arrived with 80cm's in July, 87cm's in August and 32cm's in September.

'Luke The Groomer' (he who grooms the cross country trails) reported this year saw the latest cross country skiing on the trails for many years. Luke also pointed out that the National Parks, CSIRO and one of the universities were undertaking on ground snow measuring and sampling near the 10Km trail in association with the Cloud Seeding Trial that has been underway for several years. Apart from measuring the air temperatures and humidity and other atmospheric

conditions, they were also measuring the density of the falling snow and on-ground snow amongst other factors.

It may be a coincidence but I think everyone who experienced the quality and depth of late snow last season was very happy.

#### **NEW FOR THE LODGE**

A. A defibrillator has been purchased and will probably be located in the kitchen near the first-aid kit. The model purchased has: voice instructions to guide novices and experts through each step of the process; A diagnostic system to advise when, and when not to shock patients; And a self-diagnostic system to render it 100% safe for users and patients.

In the unlikely event that it is needed, the correct procedures and steps are:

- 1. Dial 000 in the first instance and arrange for an ambulance;
- 2. Commence (manual) CPR;
- 3. Have a second person to prepare and use the defibrillator.

At all times steps 1. & 2. are the most critical, and in that order. If a second person is not available, continue step 2. until the ambulance arrives. Remember that the brain can do without oxygen for about 4 minutes before any damage is

likely; so there is always time to call an ambulance. Manual CPR is sufficient to push blood around the body and provide oxygen to the brain.

The three steps above are not only the correct sequence, but also in order of importance.

- B. There are three new leather lounges on order to replace the oldest ones for the lounge rooms. These will be placed in the 'Happy Hour' lounge room and the better of the remaining two will remain in the 'kids' area'. They should be in service for the next snow season.
- C. The Board has installed an Electrical Surge Protection system for the lodge. An electrical storm prior to last season, when the lodge was empty, caused considerable damage to some of the lodge's electronic devices and Emergency Exit Lighting. These were all repaired but at considerable expense which was just under the prescribed excess of our insurance. This surge protection should provide a better level of security for the lodge as well as members' and guests' electronic appliances if plugged in during a storm.

#### WINTER PARKING AT THE LODGE

Members are advised that early and late in the Winter season, when there is no snow on the ground, it may be possible to drive and park overnight at the lodge. The NPWS have allocated Mulubinba Lodge just three overnight parking permits for these periods. The three allocated spots are off the road and on our property, so there should be no parking on the road. This is for safety reasons in case there is a sudden change in the weather and the road needs to be cleared of snow. If parking numbers were not controlled, it could take many days to extract all vehicles in the valley so they can be taken off the mountain. The number of allocated spots per lodge is based on the land size rather than the number of rooms. If there are more cars than spaces, some will have to be left in the car park at Perisher and the expectation would be that those with a designated car park would drive those without to their cars as required.

The board will be considering how to monitor and issue these parking permits and members will be advised prior to next season.

Note that this arrangement only applies from the June long weekend to the October long weekend (i.e. the Winter season). Parking on the road, and on our land, is allowed in the Summer Season as long as cars aren't parked on vegetation.

#### **MEMBERS' FAMILY RATES**
